Note for customers:

- Any equipment installed by TICL at the Client premises for provisioning of the requested service are owned by TICL. Client agrees to replace or repay the cost invoiced by TICL in case the equipment are damaged due to negligence by Client or otherwise. In time of surrendering the service client shall hand over the equipment to TICL.
- For 5G CPE deive: In the event of damage of the device due to events apart from force majeure and within first 12 months of service subscription period, client has to pay device cost depending on the type of device (indoor or outdoor) used. Nu. 19,380 if it is Outdoor 5G CPE. Nu. 12,540 if it is Indoor 5G CPE.
- Customers availing any of the Packages will be charged in blocks of 7 days irrespective of the number of days opted to utilize the service. Our billing shall auto-renewed the service after every 7 days of initiation of billing if the service availed is more than the validity date. After the bill is generated, the client must make the payment within 10 days from the date of billing or in advance.
